

DECISION AMENDING THE BUDGET ALLOCATION FOR THE 1st 2024 CALL FOR APPLICATIONS 2024 FOR THE AWARDING OF GRANTS, ON A COMPETITIVE BASIS, FOR THE PUBLICATION ABROAD OF ILLUSTRATED WORKS

BACKGROUND FACTS

1. The object of the Consortium of the Institut Ramon Llull (the "Institut Ramon Llull") is to raise the awareness of and disseminate the Catalan language and culture in all its expressions outside the Catalan-speaking areas. In order to achieve its objectives, the Institut Ramon Llull will provide support for external relations policies in the cultural field of consortium member institutions.

2. By agreement of the Board of Directors of the Institut Ramon Llull dated 21 December 2023, the amendments to the terms and conditions governing the awarding of grants for the publication abroad of illustrated works are approved.

3. By the decision dated 17 January 2024 (DOGC no. 9085, 23 January 2024), the Agreement of the Board of Directors dated 21 December 2023, amending the terms and conditions governing the awarding of grants for the publication of illustrated works abroad, was published.

4. By decision of the Director of the Institut Ramon Llull, dated 25 January 2024 (DOGC no. 9092, of 1 February 2024), the first call for applications 2024 for the awarding of grants, on a competitive basis, for the publication abroad of illustrated works was opened.

5. The second point of this call decision establishes that the maximum amount of the call is 80,000.00 euros distributed as follows:

A maximum amount of 16,000.00 euros charged to the budget of the Institut Ramon Llull for the year 2024 with the following budget items, which have adequate and sufficient credit:

D/005/104/ 490.000173 Literature - Translation - Abroad / L125 OIL	€14,400.00

A maximum amount of 64,000.00 euros charged to the budget of the Institut Ramon Llull for the year 2025 with the following budget items, subject to the existence of adequate and sufficient credit:

D/005/104/ 490.000173 Literature - Translation - Abroad / L125 OIL	€57,600.00

It also states that the maximum allocation may be increased depending on the number of applications received and the availability of funds.



6. On 21 May 2024, the Director of the Literature and Thought Department of the Institut Ramon Llull issued a report detailing the need to increase the budget allocation contemplated for this call, given the number of applications submitted.

The Director of the Literature and Thought Department of the Institut Ramon Llull proposed an increase of TWENTY SIX THOUSAND EUROS (€26,000.00) in the budget for this call, by amending (with a reduction and an increase) the budget items initially foreseen as detailed below:

A maximum amount of 5,200.00 euros charged to the budget of the Institut Ramon Llull for the year 2024 with the following budget items, which have adequate and sufficient credit:

A maximum amount of 20,800.00 euros charged to the budget of the Institut Ramon Llull for the year 2025 with the modification (with a reduction and an increase) of the following budget items, subject to the existence of adequate and sufficient credit:

7. Making use of the powers vested in me with regard to the awarding of grants by Article 13.2.e) of the Statutes of the Institut Ramon Llull,

I HEREBY DECIDE

To amend the budget allocation for the 1st call for applications 2024 for the award of grants, on a competitive basis, for the publication abroad of illustrated works, which is set at ONE HUNDRED AND SIX THOUSAND EUROS (106,000.00 €) to be charged to the budget of the Institut Ramon Llull and distributed as follows:

A maximum amount of 21,200.00 euros charged to the budget of the Institut Ramon Llull for the year 2024 with the following budget items, which have adequate and sufficient credit:

D/005/104/ 470.000173 Literature - Translation - To private companies / L125 OIL	€150.00
D/005/104/ 490.000173 Literature - Translation - Abroad / L125 OIL	€21,050.00

A maximum amount of 84,800.00 euros charged to the budget of the Institut Ramon Llull for the year 2025 with the following budget items, subject to the existence of adequate and sufficient credit:

D/005/104/ 470.000173 Literature - Translation - To private companies / L125 OIL	€600.00
D/005/104/ 490.000173 Literature - Translation - Abroad / L125 OIL	€84,200.00



The maximum allocation may be increased depending on the number of applications received and the availability of funds.
