

Resolution opening the third 2025 call to award grants, on a competitive basis, to publish illustrated works in foreign markets.

The Consortium of the Institut Ramon Llull (hereinafter Institut Ramon Llull) aims to project and disseminate Catalan language and culture, in all of its expressions, abroad. In pursuit of these aims, Institut Ramon Llull supports the foreign affairs policies of consortium institutions in the cultural arena.

By agreements of the Board of Directors dated 16 January 2025, approving modifications to the guidelines governing the awarding of grants to publish illustrated works in foreign markets.

By resolution dated 22 January 2025 (DOGC number 9337, of 27 January 2025) announcing the agreements of the Board of Directors dated 16 January 2025, modifying the guidelines governing the awarding of grants to publish illustrated works in foreign markets.

As per articles 87 sqq. of Royal Legislative Decree 3/2002, of 24 December, approving the revised text of Public Finance Act of Catalonia, and the basic provisions of Law 38/2003, of 17 November (General Subsidies Act) and Royal Decree 887/2006, of 21 July, approving the Regulation of said law.

With the powers granted me in article 13.2 e) of the Institut Ramon Llull byways,

Now, therefore, I resolve:

1. To open the third 2025 call to award grants, on a competitive basis, to publish illustrated works in foreign markets to be carried out from the date of publication of the resolution awarding the grants until 15 November 2026.

The grants established for this call be governed by the modified guidelines approved by the Board of Directors on 16 January 2025, published in DOGC number 9337, of 27 January 2025 and the General Subsidies Act.

2. The maximum earmarked for the call be €65,000.00. This total is broken down into the following parts:

A maximum of € 13,000.00 from the Institut Ramon Llull budget for 2025. The line items budget, which are endowed with adequate and sufficient funds, are:

A maximum of € 52,000.00 from the Institut Ramon Llull budget for 2026. The line items budget, which are conditional on the adequate and sufficient funds, are:

The maximum allocation may be increased depending on the number of applications received, for an amount not exceeding that of the call, and subject to the availability of funds.

3. The period to submit applications, as per section eight, be set at 4 August to 30 October 2025, inclusive.
4. The examining body be the individual serving as the head of the Institut Ramon Llull management and the decision-making body, the individual serving as Director of Institut Ramon Llull.
5. The members of the assessment committee for this grant line are appointed by resolution of the director of the Institut Ramon Llull and is published on the Institut Ramon Llull online noticeboard.
6. The proposal for a provisional decision to award the subsidies, the decision on the inadmissibility or withdrawal of the applications and the final resolution of the call are notified to the interested parties by publishing them on the notice board of the electronic headquarters of the Institut Ramon Llull and on the notice board of the Barcelona headquarters (Avinguda Diagonal, 373, 08008 Barcelona). This publication replaces the individual notification and has the same effects.

The publication of the resolution must state that it does not exhaust the administrative channels and that resolutions on rejection and withdrawal of applications may be appealed to the Director of Institut Ramon Llull and a final appeal of the final resolution of the call may be lodged with the President of the Institut Ramon Llull Board of Directors.

If no final resolution has been handed down and notified within six months, applicants are to interpret this administrative silence as a rejection of their applications.

Lawful appeals

This resolution, which does not exhaust the administrative channels, as per articles 121 and 122 of Law 39/2015, of 1 October, on Common Administrative Procedure of Public Administration, may be appealed and any such appeals must be lodged with the President of the Institut Ramon Llull Board of Directors within one month of the day following the publication of this resolution in the Diari Oficial de la Generalitat de Catalunya (Official Gazette of the Government of Catalonia). The one-month term ends on the same date the resolution was published.
