

**Resolution opening the 1st call 2026 for the granting of subsidies on a competitive basis for the translation of original literary works and thought into Catalan and Occitan (in its Aranese variety)**

EF00499 / L0127 Ob. 1aC/2026

The purpose of the Ramon Llull Institute Consortium (hereinafter, the Ramon Llull Institute) is to project and disseminate the Catalan language and culture in all its expressions abroad. In order to achieve its objectives, the Institut Ramon Llull will support the external relations policies in the cultural field of the consortium institutions.

By Agreement of the Board of Directors of the Institut Ramon Llull dated 16 January 2025, the modification of the terms and conditions governing the granting of subsidies for the translation of original literary works and thought into Catalan and Occitan (in their Aranese variety) is approved.

By resolution dated 22 January 2025 (DOGC no. 9337, of 27 January 2025), the Agreement of the Board of Directors dated 16 January 2025 amending the terms and conditions governing the granting of subsidies for the translation of original literary works and thought into Catalan and Occitan (in their Aranese variety) is published.

In accordance with Articles 87 et seq. of the Revised Text of the Public Finance Act of Catalonia, approved by Legislative Decree 3/2002, of 24 December, and the basic precepts of Law 38/2003, of 17 November, on General Subsidies and Royal Decree 887/2006, of 21 July, approving the Regulations of the aforementioned Law;

Making use of the powers attributed to me by article 13.2 e) of the Statutes of the Institut Ramon Llull,

**Resolution:**

1. To open the 1st call 2026 for the awarding of subsidies on a competitive basis for the translation of original literary works and thought into Catalan and Occitan (in its Aranese variety) to be carried out from the date of publication of the resolution awarding the subsidies until 15 November 2027.

The subsidies provided for in this call are governed by the modification of the bases approved by Agreement of the Board of Directors dated January 16, 2025 published in the DOGC no. 9337, of 27 January 2025 and by the General Regulations on Subsidies.

2. To establish that the maximum allocation of the call is 200,000.00 euros. This amount is distributed in the following annuities:

A maximum amount of €100,000.00 charged to the Ramon Llull Institute's budget for 2026 with the following budget items, which have adequate and sufficient credit:

A maximum amount of 100,000.00 euros charged to the budget of the Institut Ramon Llull for the year 2027 with the following budget items, subject to the existence of adequate and sufficient credit:

D/005/1041/ 470.000174 Literature - Translation - Remainder - To private companies / L0127 TRD	€20,000.00
D/005/1041/ 490.000174 Literature - Translation - Remainder - Abroad / L0127 TRD	€75,000.00
D/005/1041/ 482.000174 Literature - Translation - Remainder - To other non-profit institutions and other corporate bodies / L0127 TRD	€5,000.00

In addition, it establishes that the maximum allocation can be increased depending on the applications received, for an amount not exceeding four times that of the call, and subject to budget availability

3. Establish that the deadline for submitting applications, in accordance with the eighth base, is from 16 February to 28 May 2026, both inclusive.

4. Applications and other procedures associated with the procedure for awarding and justifying subsidies must only be made electronically using the Institut Ramon Llull E-Office.

Spanish or foreign applicants residing in Spain, when submitting applications by telematic means, must be authenticated through electronic signature systems, in accordance with Article 58 of Decree 76/2020, of 4 August, on Digital Administration, as well as the regulations and criteria established by the competent bodies in the field of administration of the Generalitat.

Non-resident foreign applicants, when submitting applications electronically, must do so through a digital certificate accepted by the European Union (see the list of trusted certification companies <https://eidas.ec.europa.eu/efda/trust-services/browse/eidas/tls>) or idCAT Mobile. Only exceptionally, in the event that it has not been possible to submit applications by the aforementioned means, and with prior authorisation from the Institut Ramon Llull, they may be authenticated through the identification system in the e-Office with a username and password in accordance with the Identification and Electronic Signature Policy document.

5. The investigating body is the head of the Management of the Institut Ramon Llull and the decision-making body is the head of the Management of the Institut Ramon Llull.

6. The members of the Evaluation Committee of this line of subsidy are appointed by resolution of the head of the Management of the Institut Ramon Llull, which is published on the notice board of the Institut Ramon Llull E-Office.

7. The decision on the non-admission or withdrawal of applications and the final resolution of the call will be notified to the interested parties by publishing them on the electronic board of the Institut Ramon Llull's e-Office and on the notice board of the Barcelona headquarters (Avinguda Diagonal, 373, 08008 Barcelona). This publication replaces the individual notification and has the same effects.

The publication of the resolution must state that it does not put an end to the administrative process and that an appeal may be lodged with the head of the Management of the Institut Ramon Llull against the resolutions of

inadmissibility or withdrawal of the applications and an appeal may be lodged with the head of the Presidency of the Board of Directors of the Institut Ramon Llull against the final resolution of the call.

If the maximum period of six months has elapsed without the final resolution of the call having been issued and published, applicants may consider their applications rejected due to administrative silence.

### **Lawful appeals**

An appeal may be lodged against this resolution, which does not put an end to the administrative procedure, in accordance with Articles 121 and 122 of Law 39/2015, of 1 October, on the Common Administrative Procedure of Public Administrations, before the Chairperson of the Board of Directors of the Institut Ramon Llull, within one month from the day following the date of publication of this resolution in the Official Gazette of the Generalitat de Catalunya.
