Selection for a curatorial proposal for the participation of Catalan culture at the 61st edition of the Venice Art Biennale 2026 within the *Collateral Events* programme

The Jury of the selection process for a curatorial proposal for the participation of Catalan culture in the 61st edition of the Venice Art Biennale 2026 within the *Collateral Events* programme met at the headquarters of the Institut Ramon Llull on July 24, 2025, to evaluate the applications submitted to the selection process and which had been accepted in the second round. After the appropriate evaluations and deliberations, in accordance with section 8.2 of the Terms and Conditions, the Jury proposed the winning proposal and the four finalists to the Consorci Institut Ramon Llull. The management of the Institut approves the verdict of the Jury and issues this resolution for the purpose of making the results public and awarding the Prizes established in section 7 of the Terms and Conditions.
